"Introduction of Ordinance Authorizing the City Manager to Execute a Lease for Building 39 with Pyka Inc. Located at 950 West Tower Avenue at Alameda Point, Alameda, California, for a Term of Eight Years with a Three-Year Extension Option"

Hello Alameda City Council,

As a longtime resident of Alameda I request that you **deny** authorization of a lease for Pyka Inc at 950 West Tower Avenue, by choosing option #3 from the Alternative Actions listed in City Manager Jennifer Ott's explanation of agenda item 7-F (2023-3308):

Alternative #3: "Choose not to approve the first reading and <u>direct the City Manager to terminate</u> <u>negotiations with Pyka</u>. In this scenario, City Council should identify why Pyka is not a suitable tenant for Alameda Point so that staff directs its pursuit of a new tenant that is suitable for Alameda Point and Building 39."

I understand why supporters of the proposed lease are glad to see Pyka developing low-flying autonomous electric aircraft that run without fossil fuels. Avoidance of jet fuel is laudable. But this is not enough to offset the point that many of Pyka's "green" drones will be used to spray petroleum-based pesticides on crops. The net effect is clearly not an environmentally sustainable activity. Synthetic pesticides contaminate farm soil and seep into watersheds. Pyka partners with a company (Grupo HAME) that plans to use Pyka's aircrafts to spray pesticides in sensitive rain forest regions in Guatemala and Costa Rica. Alameda's own "Climate Action & Resiliency Plan" (CARP) expressly claims that we as a city are committed to avoiding this kind of action.

CARP includes Alameda's "Climate Emergency Declaration," signed in 2019 by the mayor and council members. It states that we understand our responsibility and interconnectedness to local and global environmentalism (*see excerpts below*).

Our city has committed in writing to these ethical goals, and shouldn't just drop them when tempted with substantial lease income. Alameda can find better avenues for economic development than a company that makes it easier to spray toxic, petroleum-based chemicals. Please deny authorization of a lease for Pyka Inc, and pursue a more suitable tenant for 950 West Tower Avenue.

We can be proud again. DO NOT inviting Pyka to bring their dirty business to Alameda Point. Their pesticides, used around the earth, will add to the harmful chemicals on land and sea. In our food.

I don't believe a pesticide drone company is the way to the future that Alamedans want. We're better than that.


Dear Mayor Marilyn Ezzy Ashcraft, Vice Mayor Tony Daysog, and Councilmembers Tracy Jensen, Trish Herrara Spencer, and Malia Vella,

I urge you to vote to reject the proposed lease of Building 39 to Pyka because their drone aircraft designed for spraying pesticides sends the wrong message about Alameda's commitment to environmental sustainability. The Earth's ecosystems are already overburdened by chemical pollution, some of which comes from the application of pesticides and herbicides to agricultural land.

Based on the reactions of Instagram users to my commentary on this subject on the Alameda Post, it appears the community agrees with me. Included below is a screenshot of the Instagram post from six days ago showing 114 likes for my viewpoint, which is a big number of likes for an Alameda Post Instagram post. None of the six comments spoke in favor of leasing to Pyka.

I recommend directing staff to seek out a different tenant for this hangar and utilize a screening process that takes into account how the company's product effects the environment. At least it should not be demonstrably harmful as is the case with aerial spraying of synthetic pesticides.

Dear Mayor Ashcraft and City Council Members Vella, Daysog, Spencer, and Jensen,

I am writing to urge you NOT to approve the ordinance for a lease of Bldg. 39 with Pyka, a company that makes autonomous aircraft for spraying pesticides on agricultural crops. Pyka is a drone company whose drones release pesticides in both the US and in sensitive agricultural areas in the global food chain. Pyka recently announced a deal with a company which owns nonorganic banana plantations in Guatemala and Costa Rica.

This drone company's pesticide drone flies in the face, literally, of all the city's policy statements about sustainability. If we agree that we all want a sustainable Alameda, why aren't we extending that philosophy to the rest of the country and the world?

Ask yourselves this: If the Alameda Point Collaborative farm was 100 acres, would you sanction aerial spraying of pesticides at Alameda Point? If not, then why stay silent and collect revenue from a company whose product is used to spray synthetic pesticides in Central and South America, or on farmland in the U.S.?

This is a critical decision- if our communities don't hold corporations responsible there is little chance of them

changing their business practices. This is an incredible opportunity to stand up for the health of our planet please seize this opportunity and say NO to this lease with Pyka.
